

THIS AGREEMENT is made the 30 December 2017

BETWEEN:

- (1) **UNITED TLD HOLDCO LTD.**, an exempted company incorporated with limited liability in the Cayman Islands with registration number 266441, and tax resident in Ireland under registered number 907361 and having its place of business in Ireland at One Clarendon Row, Dublin 2, Ireland ("United");
- (2) **RIGHTSIDE DOMAINS EUROPE LIMITED**, a private company limited by shares incorporated in Ireland (company number 499862) whose registered office is at Ten Earlsfort Terrace, Dublin 2, D02 T380, Ireland ("RDEL").

WHEREAS:

- (A) The parties wish to enter into this Agreement to set out the manner in which they shall be merged under the Act.

IT IS AGREED as follows:

1. **DEFINITIONS**

"Assets" means all of the assets of United, including those listed in Schedule 1;

6. **EFFECT OF THE MERGER**

6.1 At the Effective Time, in accordance with section 236 of the Act:

- (a) the rights, the property of every description including the Assets, choses in action, and the business, undertaking, goodwill, benefits, immunities and privileges of United, shall immediately vest in RDEL;
- (b) RDEL shall be liable for and subject, in the same manner as United, to all mortgages, charges or security interests, and all contracts, including the Contracts, obligations, claims, debts, and liabilities, including the Liabilities, of United;
- (c) an existing claim, cause or proceeding, whether civil (including arbitration) or criminal pending at the time of the Merger by or against United, shall not be abated or discontinued by the Merger but shall be continued by or against RDEL; and
- (d) a conviction, judgment, ruling, order or claim, due or to become due, against United, shall not be released or impaired by the Merger, but shall apply to RDEL instead of to United.
