Article 1 Party A agrees to assign the following mark to Party B with goodwill:

Valid Registration Period:

Article 2 Party A shall guarantee the trademark mentioned in Article 1 is free from all defects of right.

Article 3 Party A shall guarantee there are no identical or similar trademarks with the trademark mentioned in Article 1 applied or registered on similar goods in international class 25. If any, Party A shall assign the trademarks to Party B free of charge.

Article 4 Party A shall stop using the trademark from the date when this Contract takes effect.



Article 5 Party A shall, at the same time of the signing of this Agreement, subscribe two original Applications for Assignment of an Applied or Registered Trademark of the trademark mentioned in Article 1 to Party B. Party A shall keep the signature consistency on trademark assignment documents and trademark application/ registration documents. The fees for trademark assignment shall be borne by Party B.

Article 6 The both parties shall abide by all terms and conditions of this contract. The party in breach shall bear the liability for breach of contract. The contract shall continue to be performed after undertaking the liability by the default party.

Article 7 This contract shall take effect on the date it signed by the representatives of two parties.

Article 8 Any disputes during the implementation of this contract shall be settled through friendly consultation by both parties. In case no settlement to disputes can be reached through friendly consultation by both parties, any party can sue to court with jurisdiction in the residence of Party B.

Article 9 This contract is in quadruplicate, one for each party concerned and the others to be used in above-mentioned trademark assignment. The four copies have the equal legal effect.
