RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST (this "**Release**") is made effective as of March 22, 2019 (the "**Effective Date**"), by and from Comerica Bank (the "**Secured Party**") to Metal Resources, Inc. ("**Grantor**").

WHEREAS, the Secured Party and Grantor are parties to that certain Intellectual Property Security Agreement dated March 1, 2017 (the "**Security Agreement**"), pursuant to which Grantor granted Agent a security interest in the trademarks set forth in Exhibit A hereto (the "**Trademarks**");

WHEREAS, the Security Agreement has been recorded in the United States Patent and Trademark Office at Reel 6003, Frame 0353; and

WHEREAS, all obligations owing and due under the Credit Agreement (as defined in the Security Agreement) have been met in full, and the Secured Party wishes to evidence the release of its interest in the Trademarks, and retransfer and reassign to Grantor, without recourse, all of its right, title and interest in and to the Trademarks.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. **Defined Terms**. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.
2. **Release of Security Interest**. The Secured Party hereby releases, terminates, cancels, relinquishes and discharges any security interest it may have in, and any right of set off against, the Trademarks and any rights therein, including any goodwill of the business symbolized by the foregoing, all rights to sue for past, present, and future infringements thereof, and any income, royalties, and proceedings resulting therefrom, and retransfers and reassigns any and all right, title and interest it may have in and to the foregoing without recourse to Grantor.
3. **Delivery by Facsimile**. Delivery of an executed signature page to this Release by facsimile or electronic (including .pdf file) transmission shall be as effective as delivery of a signed counterpart of this Release.
