**GRANT OF**  
**SECURITY INTEREST IN TRADEMARK RIGHTS**

THIS GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS (“Agreement”), dated as of March 22, 2019 is made by each of the signatories hereto (together with any other entity that may become a party hereto as provided herein, the “Grantors”), in favor of Bank of America, N.A., a national banking association, as agent (in such capacity, the “Agent”) for the Secured Parties.

W I T N E S S E T H:

WHEREAS, the Grantors, Horizon Global Corporation (“Parent Borrower” and together with the Grantors and any other Subsidiaries of the Parent Borrower party thereto from time to time as Borrowers, collectively, “Borrowers”), the other Subsidiaries of the Parent Borrower from time to time party thereto, the financial institutions from time to time party thereto as Lenders, and the Agent have entered into that certain Amended and Restated Loan Agreement, dated as of December 22, 2015 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Loan Agreement”), which, among other things, amends and restates that certain Loan Agreement, dated as of June 30, 2015, by and among the Parent Borrower, certain of the Subsidiaries of the Parent Borrower, the Agent and the other financial institutions party thereto;

WHEREAS, pursuant to the Loan Agreement, the Lenders have severally agreed to make extensions of credit and other financial accommodations to the Borrowers upon the terms and subject to the conditions set forth therein;

WHEREAS, the Borrowers are members of an affiliated group of companies that includes each other Grantor;

WHEREAS, in connection with the Loan Agreement, the Grantors and certain other subsidiaries of the Parent Borrower have executed and delivered an Amended and Restated ABL Guarantee and Collateral Agreement, dated of March 15, 2019 which amends and restates that certain ABL Guarantee and Collateral Agreement, dated as of June 30, 2015 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Guarantee and Collateral Agreement”) in favor of the Agent for the ratable benefit of the Secured Parties;

WHEREAS, pursuant to the Guarantee and Collateral Agreement, the Grantors and the other Subsidiaries of the Parent Borrower party thereto pledged and granted to the Agent for the ratable benefit of the Secured Parties a security interest in all of their right, title and interest in Intellectual Property, including without limitation the Trademarks; and

WHEREAS, the Grantors have duly authorized the execution, delivery and performance of this Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in order to induce the Lenders to make their respective extensions of credit to

the Borrower under the Loan Agreement, each Grantor agrees, for the benefit of the Agent and the Lenders, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided or provided by reference in the Loan Agreement and the Guarantee and Collateral Agreement.

SECTION 2. Grant of Security Interest. Each Grantor hereby pledges and grants to the Agent, on behalf of and for the benefit of the Secured Parties, to secure the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Obligations, a security interest in all of its right, title and interest in, to and under such Grantor's Trademarks (including, without limitation, those items listed on Schedule A hereto), whether now owned by, or hereafter acquired by such Grantor (including under any trade name or derivations thereof).

SECTION 3. Purpose. This Agreement has been executed and delivered by Grantors for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office. The security interest granted hereby has been granted to the Agent, on behalf of the benefit of the Secured Parties, in connection with the Guarantee and Collateral Agreement and is expressly subject to the terms and conditions thereof. The Guarantee and Collateral Agreement, that certain Grant of Security Interest in Trademark Rights, dated as of June 30, 2015, made by certain of the Grantors and the other grantors party thereto in favor of the Agent, that certain Grant of Security Interest in Trademark Rights, dated as of December 22, 2015, made by certain of the Grantors, and any and all other security agreements providing for the grant of a security interest in any of the Intellectual Property of any of the Grantors to the Agent, in each case as amended, amended and restated, supplemented or otherwise modified from time to time, and all rights and remedies of the Secured Parties under all of the foregoing, shall remain in full force and effect in accordance with their terms.


