## RELEASE OF TRADEMARK SECURITY INTERESTS

This RELEASE OF TRADEMARK SECURITY INTERESTS ("Release"), as of the date effected below, is granted by JOHNSON BANK, as administrative agent ("Assignee"), in favor of CLEARWATER TECH, L.L.C., a Delaware limited liability company with its principal place of business located at 850-E Capitolio Way, San Luis Obispo, California 93401 (the "Grantor").

WHEREAS, Grantor, AQUION, INC., a Delaware corporation, ("AQUION"), and Assignee executed a certain General Intangibles Security Agreement dated as of December 4, 2013 (the "General Intangibles Security Agreement"), and, with WATER INGENUITY HOLDINGS CORP., a Delaware corporation ("WATER INGENUITY"), a Security Agreement, dated as of December 4, 2013 (collectively, the "Security Agreements");

WHEREAS, on November 10, 2015, Procam Controls, Inc., a Texas corporation ("PROCAM"), joined the Security Agreements and on that same day the Exhibits to the General Intangibles Security Agreement were amended and restated;

WHEREAS, pursuant to the Security Agreements Grantor pledged and granted to Assignee a security interest in and to all of the right, title, and interest in and to the trademark application and registrations identified in Exhibit A hereto, the associated goodwill therein, together with all proceeds and benefits of the Trademarks (the "Trademark Collateral");

WHEREAS, a notice of security interest in trademarks was recorded with the United States Patent and Trademark Office for trademark Registration Nos. 3695349; 3711546; 3816349 and trademark application Serial No. 85567951 at Reel 5189, Frame 0204, on January 8, 2014; and

WHEREAS a notice of security interest in trademarks was recorded with the United States Patent and Trademark Office for trademark Registration No. 4874308 at Reel 5667, Frame 0574, on November 12, 2015; and

WHEREAS, the Grantor has requested that the Assignee enter into this Release in order to effectuate, evidence and record the release and reassignment to the Grantor of any and all right, title, and interest the Assignee may have had in the Trademark Collateral pursuant to the Security Agreements.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignee states as follows:


