TRADEMARK ASSIGNMENT

2. If applicable, the Parties hereby request and authorize the applicable foreign authorities to record Assignee as the assignee and owner of the Assigned Trademarks.
3. This Assignment is binding upon and inures to the benefit of the Parties hereto and their respective successors and assigns.
