RELEASE OF IP SECURITY INTEREST

This **RELEASE OF IP SECURITY INTEREST**, dated as March 25, 2019, is made by Patriot Capital III SBIC, L.P., as Administrative Agent (the "**Secured Party**"), in favor of (1) Arch Global Precision LLC, (2) Jasco Tools, LLC, (3) Arch Corporate Holdings, Inc., (4) Hi-Vol Products LLC, (5) Keo Cutters, LLC, (6) Richards Micro-Tool, LLC, (7) AGP Properties LLC, (8) Keo Milling Cutters LLC, (9) Production Tool & Grinding, Inc., (10) Ultra-Dex USA LLC, (11) Voisard Tool, LLC, (12) Valley Machine, LLC, (13) Professional Machine LLC, (14) Little Rock Tools, LLC, (15) Smiths Machine LLC, (16) MSL Precision LLC, (17) Advanced Precision LLC, (18) Bob Manufacturing LLC, (19) Seabrook Medical LLC and (20) RI Carbide Tool LLC (collectively, the "**Grantor**").

WHEREAS, pursuant to the terms and conditions of that certain Patent, Trademark and Copyright Security Agreement dated as of December 2, 2014 (as amended, modified, supplemented and/or restated from time to time) and recorded with the United States Patent & Trademark Office on (A) December 12, 2014, at Trademark **Reel 5418 Frame 0268** and (B) December 12, 2014, at **Reel 5418 Frame 0393** (collectively, the "**Security Interest Grant**"), made by the Grantor in favor of the Secured Party, whereby the Grantor pledged and assigned to Secured Party, a continuing security interest in all of each Grantor's right, title and interest in and to the following, whether now owned or hereafter acquired or arising (collectively, the "**Collateral**"): all trade names, patent applications, patents, trademark applications, trademarks and copyrights, whether now owned or hereafter acquired by each Grantor, including, without limitation, those listed on Schedule A hereto, including all proceeds thereof (such as, by way of example, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof, and the goodwill of the business to which any of the patents, trademarks and copyrights relate.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby (i) terminates the Security Interest Grant, and (ii) releases, without any representation, recourse or undertaking by the Secured Party, any and all liens on, and security interests in, the Collateral, including the trademarks listed on Schedule A hereto, granted pursuant to the Security Interest Grant.




