
#### INTELLECTUAL PROPERTY TRANSFER AGREEMENT

This Intellectual Property Transfer Agreement ("<u>Agreement</u>"), effective as of October 28, 2018, is entered into by and between Cisco Systems, Inc. ("Seller"), Cisco Systems International S.A.R.L, Cisco Technologies, Inc., and Cisco Video Technologies France (collectively with Seller, "<u>Cisco</u>"), OnPrime TV, LLC (as successor in interest to OnPrime TV, Inc.) and Beaumaris Networks, LLC (together with Cisco, the "<u>Assignors</u>"), Triton US VP Acquisition Co. ("<u>VP Acquisition Co.</u>"), NDS Limited ("<u>NDS Ltd.</u>"), and NDS Americas LLC ("<u>NDS Americas</u>").

WHEREAS, pursuant to that certain Purchase Agreement between Seller and Triton UK Bidco Limited ("<u>Purchaser</u>"), dated as of April 30, 2018 (the "<u>Purchase Agreement</u>"), Seller has agreed to sell to Purchaser, and Purchaser has agreed to purchase from Seller, certain equity interests and other assets (the "<u>Acquisition</u>");

WHEREAS, the Assignors are the owners of certain patents and patent applications identified in Schedules A, B, and C of Schedule 1.1(h)(ii) of the Disclosure Letter ("<u>Assigned Patents</u>"), certain trademark registrations and applications identified in Schedule 1.1(h)(ii) of the Disclosure Letter ("<u>Assigned Trademarks</u>"), and certain internet domain name registrations identified in Schedule 1.1(h)(ii) of the Disclosure Letter ("<u>Assigned Domain Names</u>" and together with the Assigned Patents and the Assigned Trademarks, the "<u>Assigned IP Assets</u>"), in each case, which relate to either the VP Business or the NDS Business (each as defined below). The Assigned IP Assets are, in each case, as amended and duplicated herein in Schedule A and Schedule B hereto;

WHEREAS, in connection with the Acquisition, the Assignors have agreed to assign to VP Acquisition Co. all of the Assignors' right, title, and interest in and to the subset of the Assigned IP Assets that is related to the video processing business being transferred in the Acquisition (the "<u>VP Business</u>" and collectively, the "<u>VP Assigned IP Assets</u>"). The VP Assigned IP Assets are identified in Schedule A hereto;



WHEREAS, in connection with the Acquisition, the Assignors have agreed to assign to NDS Ltd. all of the Assignors' right, title, and interest in and to the subset of the Assigned IP Assets that are related to the NDS Business (the "NDS Assigned IP Assets"). The NDS Assigned IP Assets are identified in Schedule B hereto; and

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the Assignors, NDS Americas, and NDS Ltd. hereby agree as follows:

1. <u>Order of Operations</u>. The transfers herein shall occur in the numerical order in which they appear in this document.

# 2. <u>Assignment of VP Assigned IP Assets.</u>

- a. <u>Conveyance and Acceptance of VP Assigned IP Assets</u>. Immediately following the Closing, the Assignors hereby sell, transfer and assign to VP Acquisition Co., and VP Acquisition Co. hereby accepts, all of such Assignors' right, title, and interest in and to the following as set forth on Schedule A hereto:
- i. the subset of the Assigned Patents that are related to the VP Business, as set forth on Schedule A hereto (the "VP Assigned Patents"), all rights of action pertaining to such VP Assigned Patents, including without limitation the right to sue and recover for past, present, and future infringement thereof, the right to secure registration of such VP Assigned Patents and of this Agreement, the right to initiate other proceedings before any United States, foreign, supranational, federal, state, provincial, municipal or local government, government agency, court of competent jurisdiction, administrative agency or commission or other governmental or regulatory authority or instrumentality ("Governmental Authority") with respect to such VP Assigned Patents, and the right to claim priority, file foreign counterparts, and make applications for reissue and reexamination with respect to any of such VP Assigned Patents;
- ii. the subset of the Assigned Trademarks that are related to the VP Business as set forth on Schedule A hereto (the "<u>VP Assigned Trademarks</u>"), the goodwill of the business connected with the use of and symbolized by the VP Assigned Trademarks, the right to sue and recover for past, present, or future infringement thereof, the right to secure registration of such VP Assigned Trademarks and of this Agreement, and the right to initiate other proceedings before all Governmental Authorities with respect to such VP Assigned Trademarks; and
- iii. the subset of the Assigned Domain Names that are related to the VP Business as set forth on Schedule A hereto (the "VP Assigned Domain Names"), the right to sue and recover for past, present, or future infringement thereof, the right to secure registration of such VP Assigned Domain Names and of this Agreement, and the right to initiate other proceedings before all Governmental Authorities with respect to such VP Assigned Domain Names.



- 4. <u>Assignment of NDS Assigned IP Assets</u>.
  - a. <u>Conveyance and Acceptance of NDS Assigned IP Assets.</u>

the Assignors hereby sell, transfer and assign to NDS Ltd., and NDS Ltd. hereby accepts, all of such Assignors' right, title, and interest in and to the following as set forth on Schedule B hereto:

- i. the subset of the Assigned Patents that are related to the NDS Business as set forth on Schedule B hereto (the "NDS Assigned Patents"), all rights of action pertaining to such NDS Assigned Patents, including without limitation the right to sue and recover for past, present, and future infringement thereof, the right to secure registration of such NDS Assigned Patents and of this Agreement, the right to initiate other proceedings before all Governmental Authorities with respect to such NDS Assigned Patents, and the right to claim priority, file foreign counterparts, and make applications for reissue and reexamination with respect to any of such NDS Assigned Patents;
- ii. the subset of the Assigned Trademarks that are related to the NDS Business as set forth on Schedule B hereto (the "NDS Assigned Trademarks"), the goodwill of the business connected with the use of and symbolized by the NDS Assigned Trademarks, the right to sue and recover for past, present, or future infringement thereof, the right to secure registration of such NDS Assigned Trademarks and of this Agreement, and the right to initiate other proceedings before all Governmental Authorities with respect to such NDS Assigned Trademarks; and
- iii. the subset of Assigned Domain Names that are related to the NDS Business as set forth on Schedule B hereto (the "NDS Assigned Domain Names"), the right to sue and recover for past, present, or future infringement thereof, the right to secure registration of such NDS Assigned Domain Names and of this Agreement, and the right to initiate other proceedings before all Governmental Authorities with respect to such NDS Assigned Domain Names.

# 6. Further Actions.

- a. <u>Authorization</u>. Assignors hereby authorize and request that the Commissioner for Patents, the Commissioner for Trademarks, and any other sovereign official holding a corresponding position of authority in any other state or country, record this Agreement and the assignments of the Assigned IP Assets herein. Assignors will, at VP Acquisition Co.'s or NDS Ltd.'s request and expense, as applicable, take any and all reasonable actions, including without limitation, the execution, acknowledgment, and delivery of any and all documents, that VP Acquisition Co. or NDS Ltd., as applicable, may reasonably request to enable VP Acquisition Co. or NDS Ltd., as applicable, to record and perfect VP Acquisition Co.'s or NDS Ltd.'s respective interests in and to the Assigned Patents and Assigned Trademarks as intended under this Agreement.
- b. <u>Registrars</u>. Assignors hereby acknowledge and agree that each internet domain name registrar (the "<u>Registering Authority</u>") of the Assigned Domain Names is authorized to transfer and record in the name of VP Acquisition Co. or NDS Ltd., as

applicable, ownership of and administrative contact for all of the respective Assigned Domain Names transferred to it hereunder. Assignors will, at VP Acquisition Co.'s or NDS Ltd.'s request and expense, as applicable, take any and all reasonable actions, including without limitation, the execution, acknowledgment, and delivery of any and all documents, that Purchaser may reasonably request to record and perfect VP Acquisition Co.'s or NDS Ltd.'s respective interests in and to the Assigned Domain Names. Without limiting the foregoing, at VP Acquisition Co.'s or NDS Ltd.'s request and expense, as applicable, Assignors will cooperate with VP Acquisition Co. or NDS Ltd., respectively, to (i) complete any registrant name change agreement or other form required by any applicable Registering Authority to effect or record the assignment contemplated by this Agreement; (ii) submit those registrant name change agreements or other forms to the Registering Authority in accordance with the Registering Authority's policies and rules; and (iii) take any further actions required by the Registering Authority's policies and rules to transfer the respective Domain Names to NDS Ltd. or VP Acquisition Co., as applicable.

- 7. <u>Governing Law.</u> This Agreement and all claims arising out of this Agreement shall be governed by, and construed in accordance with, the internal Laws of the State of New York (whether arising in contract, tort, equity or otherwise), without regard to any conflicts of law principles that would result in the application of any law other than the law of the State of New York.
- 8. <u>Counterparts</u>. This Agreement may be executed by facsimile signatures and in any number of counterparts with the same effect as if all signatory parties had signed the same document. All counterparts shall be construed together and shall constitute one and the same instrument.
- 9. <u>Purchase Agreement</u>. Notwithstanding anything in this Agreement to the contrary, the sale, transfer, and assignment effectuated hereby is subject in all respects to the terms and conditions of the Purchase Agreement and nothing in this Agreement, express or implied, is intended or shall be construed to expand or defeat, impair or limit in any way the rights, obligations, claims or remedies of Purchaser, NDS Ltd., or Assignors, as set forth in the Purchase Agreement. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms of this Agreement, the terms of the Purchase Agreement shall govern.


