Release of Security Interest in Trademarks

This Release of Security Interest in Trademarks (the "Release") is made as of February 11, 2019, by GOLDMAN SACHS BANK USA, in its capacity as collateral agent pursuant to the Credit Agreement (in such capacity, the "Collateral Agent") in favor of API Healthcare Corporation, a Wisconsin corporation, Concerro, Inc., a California corporation, VVC Holding Corp., a Delaware corporation (as successor in interest to Fayola Sunrise LLC, a Delaware limited liability company) and VVC Holding Corp., a Delaware corporation (as successor in interest to Ventura Rainbow LLC, a Delaware limited liability company) (individually, a "Pledgor", and, collectively, the "Pledgors").

WITNESSETH:

WHEREAS, pursuant to the terms and conditions of that certain First Lien Security Agreement dated as of July 10, 2018 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") in favor of the Collateral Agent the Pledgors entered into that certain First Lien Trademark Security Agreement dated as of July 10, 2018 (the "First Lien Trademark Security Agreement");

WHEREAS, pursuant to the terms and conditions of the First Lien Trademark Security Agreement and the First Lien Security Agreement each Pledgor pledged and granted to the Collateral Agent for the benefit of the secured parties a lien on and security interest in all of the right, title and interest of such Pledgor in, to and under the Trademark Collateral (as defined in the First Lien Trademark Security Agreement), including, without limitation, the trademarks set forth on Schedule I attached hereto (the "Trademarks");

WHEREAS, the First Lien Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 11, 2018 at Reel/Frame 6377/0385; and

WHEREAS, the Collateral Agent desires to release, terminate and discharge the security interest and lien in the Trademark Collateral.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent on behalf of itself and the secured parties, hereby terminates the First Lien Trademark Security Agreement and releases, terminates, discharges and relinquishes unto each applicable Pledgor the continuing security interest in, and lien on, the Trademark Collateral and otherwise assigns, grants and conveys to each applicable Pledgor, without recourse, any and all right, title and interest the Collateral Agent or the secured parties may have in, to or under to the Trademark Collateral in order to re-vest in each applicable Pledgor full and unencumbered title to said Trademark Collateral.
