**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of March 28, 2019 (the "Effective Date"), is made by **ABLECO FINANCE LLC**, a Delaware corporation, in its capacity as collateral agent (the "Collateral Agent"), in favor of **JENNY CRAIG, INC.**, a Delaware corporation (the "Grantor").

WHEREAS, the Collateral Agent entered into that certain Trademark Security Agreement dated as of May 14, 2002, with Jenny Craig, Inc., notice of which was recorded by the United States Patent and Trademark Office on May 21, 2002 at Reel 2510, Frame 0336 (the "Trademark Security Agreement");


WHEREAS, Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a security interest (the "Security Interest") in favor of the Collateral Agent, in and to its Trademark Collateral (as defined in the Trademark Security Agreement), which includes the trademarks and trademark applications listed in Schedule I; and

WHEREAS, the Collateral Agent has terminated and released the Security Interest in all such Trademark Collateral, and the Collateral Agent wishes to confirm such termination and release as set forth herein.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantor, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest.
