**BETWEEN**

(1) **EDRINGTON DISTILLERS LIMITED** incorporated in Scotland with registered number SC014472 and having its registered office at 100 Queen Street, Glasgow G1 3DN (Assignor);

and

(2) **GLEN TURNER COMPANY LIMITED** incorporated in England with registered number 1595703 and having its registered office at Bridge House, London Bridge, London SE 9QR (Assignee).

**BACKGROUND**

A The Assignor is the proprietor of the Business IPR including, but not limited to, the Trade Marks and Domain Names (as after defined).

B Under the APA, the Assignor has agreed to assign the Business IPR to the Assignee and the parties wish to record their agreement in writing.

**IT IS AGREED AS FOLLOWS**

**1 DEFINITIONS AND INTERPRETATIONS**

1.1 The following words and expressions shall have the following meanings unless the context requires otherwise:

**APA** - means the asset purchase agreement entered into between the Assignor and Assignee dated TBC November 2018;

**Assignment** - means this intellectual property rights assignment entered into between the Assignor and Assignee;

**Business** - means the business of marketing and sales of products bearing the Name as carried on by the Assignor as at the Effective Date;

**Business IPR** - means all the Intellectual Property Rights owned or used by the Assignor exclusively in connection with the Business (whether prior to, on or after the date of this Assignment) including, without limitation, the Name and those listed in Part A of the Schedule;

**Domain Names** - means the domain names set out in Part A of the Schedule;

**Effective Date** -- means the date of this Assignment;

**Intellectual Property Rights** - means patents, trade marks, service marks, trade names, domain names, registered designs, designs, semiconductor topography rights, database rights of unfair extraction and reutilisation, goodwill and the right to sue for passing off, copyrights and other forms of intellectual or industrial property, know how, inventions, formulae, confidential or secret processes and information, and any other protected rights and assets, and any licences and permissions in connection with the foregoing (in each case in any part of the world, whether registered or registrable or not and if registered or registrable

for their full period of registration with all extensions and renewals, and including all applications for registration or otherwise);

**Name** - means Cutty Sark or any name or sign which includes the word Cutty or Sark or which graphically represents the Cutty Sark brand or products.

**Schedule** - means the schedule annexed to and forming part of this Assignment;

**Trade Marks** - means the registered trade marks and trade mark applications set out in Part A of the Schedule; and

**Transfer Formalities** – means all formalities (including the provision of online domain name account details and passwords, the selection and completion of relevant change of registrant and change of administrative contact functions within such domain name accounts and the provision of email or other online notice or confirmation notifying the registrar of the transfer) that are reasonably required to transfer full and unconditional ownership and technical control of the Domain Name to the Assignee, including the change of registrant name, change of administrative contact and, where required by the Assignee, change of registrar.

## **2 ASSIGNATION AND TRANSFER**

2.1 In consideration of the sums paid under the APA (receipt of which the Assignor hereby acknowledges) and the sum of ONE POUND STERLING (£1) receipt of which is hereby acknowledged, and with effect from the Effective Date the Assignor hereby:

2.1.1 assigns to the Assignee absolutely any and all Business IPR owned by the Assignor and all its right title and interest in and to any other Business IPR insofar as it has any which may accrue together with:

- (a) any and all goodwill attached thereto;
- (b) all the rights, powers, privileges and immunities and advantages conferred on the proprietor;
- (c) all causes or rights of action, actually or contingent and the right to recover damages or pursue any form of financial remedy in respect of any past, existing or future infringements; and
- (d) any and all common law rights and remedies in relation to such Business IPR available to the Assignor as at the date of this Assignment; and

2.1.2 transfers ownership and control of the Domain Names to the Assignee, by completing the Transfer Formalities as soon as practicable following the date of this Assignment.

## **3 FURTHER ASSURANCE**

3.1 The Assignor covenants that, at the cost and request of the Assignee (save for those costs and expenses which are incurred by the Assignor and which relate exclusively to the registration of any of the trade marks listed in part B of the Schedule in the name of the Assignor (where such registration in the name of the Assignor is necessary to ultimately register such trade marks in the name of the Assignee) at any time and from time to time, it shall execute such deeds or documents and do such acts or things as may be necessary or desirable to give effect to this Assignment

- 3.2 The Assignor shall deliver to the Assignee all its files and documents (including instruments of title and certificates of trade mark registration, and the assignment agreement between BB&R Spirits Limited and the Assignor (or its Affiliates) relating to the trade marks detailed in Part B of the Schedule) relating to the prosecution and maintenance of the Business IPR within such time as is reasonably possible and in any event no later than fourteen (14) days from the date of signing hereof and shall do all such things (including but not limited to signing mandates) to procure that the Assignee can access (and seek delivery of, where appropriate) files and documents held by its agents in respect of the prosecution and maintenance of the Business IPR.

#### **4 COUNTERPARTS**

- 4.1 This Assignment may be executed in any number of counterparts and by each of the parties on separate counterparts.
- 4.2 Where executed in counterparts:
- 4.2.1 unless otherwise agreed between the parties, this Assignment shall not take effect until each of the counterparts has been delivered in accordance with the Legal Writings (Counterparts and Delivery) (Scotland) Act 2015 (**Counterparts Act**);
- 4.2.2 each counterpart will be held as undelivered until the parties agree a date on which the counterparts are to be treated as delivered;
- 4.2.3 the counterparts shall be treated as a single document pursuant to the Counterparts Act;
- 4.2.4 the parties may choose to evidence the date of delivery of this Assignment by inserting it at the top of the first page of this Assignment in the blank provided for the delivery date;
- 4.2.5 the parties agree that where a person is nominated under section 2(1) of the Counterparts Act to take delivery of one or more of the counterparts, the obligations and/or duties of that person under section 2(3) of the Counterparts Act shall be excluded and such person shall hold such counterparts in accordance with any other arrangements agreed between the parties. The parties agree that this clause is for the benefit of any such nominated person and can be relied upon by such person notwithstanding that such person may not be a party to this Assignment.

#### **5 GOVERNING LAW AND JURISDICTION**

- 5.1 This Assignment and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the law of Scotland.

5.2 The parties irrevocably agree that the courts of Scotland shall have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Assignment or its subject matter or formation (including non-contractual disputes or claims).


