RELEASE OF SECURITY INTEREST

WHEREAS, AMERICAN AUGERS, INC., a Delaware corporation (as the successor-in-interest of TRENCOR, INC., a Texas corporation) (the "Debtor") for the benefit of Bank One, NA, as Agent, 1 Bank One Plaza, Mail Code II1-0631, Chicago, Illinois 60670 (the "Secured Party"), entered into that certain Intellectual Property Security Agreement dated as of April 11, 2003 (the "Security Agreement"); and


