ASSIGNMENT

WHEREAS, Assignor has adopted and is using the trademarks shown on Schedule A attached hereto and made a part hereof and Assignor is the owner of all worldwide right, title, and interest in and to the trademarks shown on Schedule A, including the listed U.S. trademark registrations and applications, and all common law rights in said trademarks, together with the goodwill of the business symbolized by said trademarks; and

WHEREAS, Assignor desires to assign, and Assignee desires to acquire all worldwide right, title and interest in and to the trademarks shown on Schedule A, including the listed U.S. trademark registrations and applications, and all common law rights in said trademarks, together with the goodwill of the business symbolized by said trademarks;

NOW THEREFORE, for [REDACTED] and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor has agreed to sell, convey, transfer, assign, and deliver and by these presents does hereby sell, convey, transfer, assign, and deliver unto Assignee, its successors and assigns, the entire worldwide right, title, and interest in, to, and under the said trademarks listed on Schedule A attached hereto and made a part hereof, including the U.S. trademark registrations and applications listed on Schedule A, and all common law rights in said trademarks, together with the goodwill of the business symbolized by the trademarks and the registrations thereof, and all income, royalties, or payments due or payable as of the effective date, and all rights to sue for past, present, and future infringements of the foregoing and the rights to settle such suits, the same to be held and enjoyed by the said Assignee for its own use, and for the use of its successors, assigns, or other legal representatives.

Assignor shall, upon the reasonable request of Assignee and at the Assignee's expense, execute, and deliver such additional documents and take such additional actions as may be necessary or convenient for the purpose of evidencing or perfecting any rights or interests arising under this Agreement.

This Agreement fully and completely divests Assignor of any and all worldwide right, title and interest in, to and under the aforesaid trademarks listed on Schedule A, including the U.S. trademark registrations and applications listed on Schedule A, and all common law rights in said trademarks, and the goodwill of the related business. Assignor will not adopt any trademarks marks similar to those on Schedule A in the future.

This Agreement may be signed using one or more counterparts, each of which when signed shall be deemed to be an original, and all of which when taken together shall constitute one and the same agreement.
