## DEED OF ASSIGNMENT

THIS ASSIGNMENT is made this 21 day of March 2019

BETWEEN

WHEREAS the Assignor is the proprietor of USA Trademark Regn. In consideration of good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby assigns to Assignee all right, title and interest in the Registration, together with the goodwill of the business in connection with which the Mark is used, and including the subject matter of all claims which may be obtained therefrom for Assignee's own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, together with all claims for damages by reason of past, present or future infringement or other unauthorized use of the Mark, with the right to sue for the use and enjoyment of its successors, assigns or other legal representatives.

The Assignor shall at the discretion and expense of the Assignee execute any further document and do any such thing as the Assignee may require to enable the Assignee to become registered as proprietor of the Trade Mark and to secure the benefits of the rights hereby assigned.


The Assignor hereby warrants that:

1. it is the proprietor of the Trade Mark and has the full power to enter into this Assignment;
2. it has not granted any licenses to use the Trade Mark;

3. it has not, either by act or omission caused and permitted anything to be done which might endanger the validity of the Trade Mark or the ability of the Assignee to register this Assignment;
4. it has not knowingly withheld from the Assignee knowledge of any circumstances that may endanger the validity of the Trade Mark or the ability of the Assignee to register this Assignment.


