ASSIGNMENT AND COEXISTENCE AGREEMENT

This Assignment and Coexistence Agreement (“Agreement”), is entered into and made effective as of January 15, 2019 (the “Effective Date”), by and among Curse LLC and Twitch Interactive, Inc., (collectively “Curse”), and Wikia, Inc., a Delaware corporation with its principal place of business at 360 3rd Street, Suite 750, San Francisco, CA 94107 (“Buyer”) (collectively, the “Parties” and each individually, a “Party”).

RECITALS

WHEREAS, the Parties (or their Affiliates) have entered into that Asset Purchase Agreement, dated December 11, 2018 (the “Purchase Agreement”) whereby Buyer has agreed to purchase from Curse, and Curse has agreed to sell, convey, assign, transfer and deliver the trademarks set forth in Exhibits 1 and 3 of this Agreement and the domains set forth in Exhibit 5. “Affiliate” means, with respect to any Person, any Person (as defined below) that directly, or indirectly through one or more intermediaries, Controls or is Controlled by or is under common Control with such Person. “Control” means, with respect to any Person, the power to direct the management and policies of such Person, directly or indirectly, whether through the ownership of voting securities, by Contract, or otherwise and the term “Controlled” has a meaning correlative with the foregoing;

WHEREAS, Curse uses and has used the trademarks listed in Exhibits 1, 2, 3 and 4 to this Agreement worldwide in connection with games, software, gaming communities, content creation, community servers, voice and video messaging, game and content distribution, advertising and entertainment services, among other services, and owns the domains listed in Exhibit 5 and 6 to this Agreement;

WHEREAS, the Parties wish to define the scope of ownership and use of the Curse and Curse-based trademarks;

WHEREAS, Curse will continue to own and use the CURSEFORGE marks in Exhibit 2, as well as the CURSEFORGE (stylized) common law marks in Exhibit 4 (collectively, the “CFG Marks”), and the CURSE-based domains in Exhibit 6, in connection with developing, distributing and supplying games, software (including, but not limited to, video game modification software or code (“mods”) and/or video game add-on software or code (“add-ons”)), modification management services, add-on management tools, overlays, plug-ins and related products and services (the “Mod Field”). Products and services described herein as the “Mod Field” include: (i) Curse’s core websites, including curseforge.com; (ii) databases and data repositories containing relevant code; (iii) software for content creation, hosting content, uploading and reviewing content, and mobile applications providing substantially similar services; (iv) developing, distributing and supplying games, software (including, but not limited to, video game modification software or code and/or video game add-on software or code, modification management services, add-on management tools, overlays, plug-ins and related products and services); (v) software developer kits; and (vi) troubleshooting and support services. For sake of clarity, Curse will: (1) not use the CURSE mark with the UNION FOR GAMERS mark, but to the extent Curse uses CURSE in connection with UNION FOR GAMERS on third party platforms, for instance, on multi-channel

networks, Curse will phase out use of the CURSE mark and/or rebrand as soon as it is permitted to do so by the third party platform provider; (2) not continue to prosecute or maintain the applications and registrations for the CURSE UNION FOR GAMERS Design marks in Exhibit 8 and will allow them to go abandoned or lapse; (3) not use the Flame Logo in Exhibit 3 with its CFG Marks; and (4) only use CURSEFORGE-based domains and will not use other CURSE-based domains on Exhibit 6, except that Curse may continue to redirect traffic to its CURSE-based domains on Exhibit 6 and utilize such domains which are only used for technical purposes (e.g., to provide stay-behind VOIP services).

WHEREAS, Curse will continue to own and use all non-CURSE based trademarks in Exhibit 2 to this Agreement, including UNION FOR GAMERS (without CURSE, as described above) and the Game Controller Design marks, as well as the non-CURSE based common law marks in Exhibit 4, including the modified Anvil Logo (without the Flame Logo), and the non-CURSE based domains in Exhibit 6 worldwide in any manner and in connection with any field.

WHEREAS, Buyer will own and use the CURSE and CURSE based trademarks in Exhibit 1 to this Agreement, as well as the common law marks in Exhibit 3, including the Flame Logo (collectively, the “Curse Marks”) and the domains in Exhibit 5, worldwide in any manner and in connection with any field other than the Mod Field (“Buyer Field”); provided, that regardless of the definition of Mod Field, the Buyer Field includes, but is not limited to: (i) software for using, downloading and accessing games, gaming networks and portals; (ii) non-software information repositories; (iii) mobile applications; (iv) software-as-a-service functionality relating to gaming or other pop culture fields; (v) advertising services and systems; and (vi) the sale of advertisements, including custom advertising content. For clarity, except as stated in the foregoing sentence, Buyer will not use the Curse Marks in the Mod Field. Buyer will not use the Curse Marks with modification management services, add-on management tools, overlays, plug-ins and related products and services. Without limiting Curse’s right to use the CFG Marks as identified in this Agreement, Seller will not retain any rights to, and will not use, the Candlekeep Marks in any field.

WHEREAS, Buyer will own and use all non-CURSE based trademarks in Exhibit 1 to this Agreement, including GAMEPEDIA, as well as the non-CURSE based common law marks in Exhibit 3 and the non-CURSE based domains in Exhibit 5 worldwide in any manner and in connection with any field.

NOW THEREFORE, in consideration of the mutual covenants, terms and conditions herein and in the Purchase Agreement and for good and valuable consideration, the receipt of which is hereby acknowledged, the parties agree as follows:

ARTICLE 1
ASSIGNMENT OF RIGHTS.

As of the Effective Date, Curse, does hereby assign to Buyer:

(a) all right, including common law rights, title and interest in the United States of America and all other countries and jurisdictions of the world in and to the trademarks set forth in Exhibits 1 and 3 of this Agreement (with the Curse Marks for use in the Buyer Field only) together with the goodwill of the business symbolized by said trademarks and applications thereof and that

portion of the business in the Buyer Field which is ongoing and existing to which the trademarks pertain. For sake of clarity, Curse retains its right, including common law rights, title and interest in the United States of America and all other countries and jurisdictions of the world in and to the CFG Marks for use in the Mod Field together with the goodwill of the business symbolized by said trademarks and applications thereof and that portion of the business in the Mod Field which is ongoing and existing to which the trademarks pertain; and

(b) all right, title, and interest in and to the domain name registrations listed in Exhibit 5.

ARTICLE 2

RIGHTS IN AND OBLIGATIONS REGARDING THE TRADEMARKS.

2.1 Obligations of Curse. Curse will not use or apply to register the CFG Marks in the Buyer Field, and will not oppose, cancel, invalidate, challenge or contest (or aid others in doing so) Buyer's use, applications to register, or registrations for the Curse Marks in the Buyer Field.

2.2 Obligations of Buyer. Buyer will not use or apply to register the Curse Marks in the Mod Field, and will not oppose, cancel, invalidate, or otherwise challenge or contest (or aid others in doing so) Curse's applications to register, or registrations for the CFG Marks in the Mod Field.

2.3 Cooperation as to Trademark Prosecution and Execution of Other Documents. Exhibit 7 sets forth the confirmation of rights for recordation by Buyer. The Parties agree to cooperate to effect the intent and terms of this Agreement, and each Party agrees to promptly execute any further agreements, consents or other documents which may be necessary or requested by the other Party in order to register the Curse and CFG Marks, or as may otherwise be needed.

2.4 Cooperation as to Prevention of Confusion. The Parties agree that no confusion is likely to result from the Parties' concurrent use and registration of the Curse and CFG Marks for their respective goods and services. The Parties are not aware of any existing confusion and do not believe confusion is likely to arise from Curse's use of the CFG Marks in the Mod Field and Buyer's use of the Curse Marks in the Buyer Field for their respective goods and services. In the unlikely event that confusion should arise, the Parties will take reasonable and adequate action to (a) notify each other of any incidents of actual confusion of which they become aware, (b) correct such confusion, and (c) prevent future confusion.

2.5 Scope of Agreement: The geographic scope of this Agreement is worldwide.

2.6 Enforcement Against Third Parties: This Agreement does not restrict or affect either Party's right to enforce its respective marks or rights therein against any third party.

ARTICLE 3

TERM AND TERMINATION.

3.1 Term. This Agreement will begin on the Effective Date and will remain in effect in perpetuity thereafter unless either Party abandons its rights in its respective marks in accordance

with applicable law, for example with respect to Lanham Act, 15 U.S.C. § 1127 in the United States.

3.2 No Injunctive Relief. Each party's rights and remedies in the event of a breach or alleged breach of this Agreement by the other party shall be limited to such party's right, if any, to recover damages in an action at law, and in no event shall either party be entitled by reason of any such breach or alleged breach to enjoin, restrain or seek to enjoin or restrain, the other party's rights under this Agreement.

3.3 Survival. The rights and obligations of the Parties contained in the Recitals and Articles 1, 2, 3, 4 will survive the termination of this Agreement or of any rights granted hereunder.

ARTICLE 4 GENERAL

4.1 Assignment. This Agreement extends to, inures to the benefit of, and is binding upon the Parties and their respective directors, officers, partners, proprietors, attorneys, agents, servants, employees, representatives, Affiliates, subsidiaries, shareholders, predecessors, and successors and assigns. This Agreement is not assignable or transferable, in whole or in part, by either Party without the prior written consent of the other Party, which consent shall not be unreasonably withheld, provided that either Party may assign this Agreement or part thereof and its rights and obligations hereunder without consent to any of its Affiliates or to any successor entity upon a merger, reorganization, or sale of all or substantially all of such Party's assets or stock that relate to this Agreement or the applicable part thereof, in each case so long as such assigning Party remains ultimately liable for its respective obligations under this Agreement.

4.2 Public Announcements. Neither Party will make any public announcements or issue or distribute any press releases related to this Agreement or the transactions contemplated hereby, in each case except as otherwise expressly provided in the Purchase Agreement.

4.3 Representation as to Authority. The Parties represent and warrant that they have the sole right and exclusive authority to execute this Agreement and that they have not sold, assigned, transferred, conveyed, or otherwise disposed of any interest, right, claim or demand, or portion thereof, relating to any matter in this Agreement.

4.4 Headings. The headings in this Agreement are for reference only and will not affect the interpretation of this Agreement.

4.5 Governing Law and Jurisdiction. This Agreement shall be governed by, and construed in accordance with, the laws of the State of Delaware, without giving effect to any choice or conflict of law, provision, or rule that would cause the application of laws of any other jurisdiction. In any action among or between any of the Parties arising out of or relating to this Agreement, including any action seeking equitable relief, each of the parties irrevocably and unconditionally consents and submits to the exclusive jurisdiction and venue of the state and federal courts located in Wilmington, Delaware. Each Party hereby irrevocably waives all right to trial by jury in any legal proceeding (whether based on Contract, tort, or otherwise) arising out of or relating to this Agreement.

4.6 Nonexclusive Remedy. Except as expressly set forth in this Agreement, the exercise by either Party of any of its remedies under this Agreement will be without prejudice to its other remedies under this Agreement or otherwise

4.7 Severability. If any term or other provision of this Agreement is invalid, illegal, or incapable of being enforced by any rule, applicable laws, or public policy, all other conditions and provisions of this Agreement shall nevertheless remain in full force and effect so long as the economic or legal substance of the transactions contemplated by this Agreement is not affected in any manner adverse to any party hereto. Upon such determination that any term or other provision is invalid, illegal, or incapable of being enforced, the parties shall negotiate in good faith to modify this Agreement so as to effect the original intent of the parties to the fullest extent possible.

4.8 Amendment and Modification; Waiver. This Agreement may be amended or waived only in a writing signed by the Parties. No waiver of any provision hereunder or any breach or default thereof shall extend to or affect in any way any other provision or prior or subsequent breach or default, and no failure or delay to enforce, or partial enforcement of, any provision hereof shall operate as a waiver of such provision or of any other provision.

4.9 Notices. All notices, requests, consents, claims, demands, waivers and other communications hereunder shall be in writing and shall be deemed given if delivered personally or by commercial delivery service, or mailed by registered or certified mail (return receipt requested) or sent via electronic mail to the parties hereto at the following address (or at such other address for a party as shall be specified by like notice):

4.10 Relationship of Parties. The Parties to this Agreement are independent contractors and this Agreement will not establish any relationship of partnership, joint venture, employment, franchise, or agency between the parties. Neither Party will have the power to bind the other or incur obligations on the other's behalf without the other's prior written consent.

4.11 Entire Agreement. This Agreement and the Purchase Agreement constitute the entire agreement among the Parties with respect to the subject matter hereof and thereof and supersede all prior (but not concurrent) agreements and undertakings, both written and oral, among the Parties, or any of them, with respect to the subject matter hereof and thereof.

4.12 Third-Party Beneficiaries. This Agreement is for the sole benefit of the Parties hereto and their respective successors and permitted assigns and nothing herein, express or implied, is intended to or will confer upon any other Person any legal or equitable right, benefit, or remedy of any nature, under or by reason of this Agreement. "Person" means an individual, corporation, partnership, joint venture, limited liability company, governmental authority, unincorporated organization, trust, association, or other entity. Notwithstanding the foregoing, Curse's Affiliates are express third party beneficiaries under this Agreement.

4.13 Counterparts. This Agreement may be executed and delivered in one or more counterparts, either manually or electronically (including by PDF and electronic mail), each of which shall be deemed to be an original but all of which together shall constitute one and the same agreement. No counterpart shall be effective unless and until each Party has executed at least one counterpart.
