**REASSIGNMENT AND RELEASE OF SECURITY INTEREST**

This Reassignment and Release of Security Interest is executed as of March 29 2019 by COMERICA BANK, a banking corporation organized under the laws of the state of Texas (“Assignor”) for the benefit of VANLAW FOOD PRODUCTS, INC., a California corporation (“Assignee”), with its principal executive office located at 2325 Moore Avenue, Fullerton, California 92833.

A. Now, therefore, Assignor agrees that it (i) terminates, releases and discharges its security interest in the Intellectual Property, (ii) waives and relinquishes all rights, powers, privileges and remedies with respect to the Intellectual Property, (iii) reassigns, grants and conveys to Assignee, without warranty or recourse, any and all right, title and interest of Assignor in the Intellectual Property and (iv) terminates the Security Agreement.


