Pursuant to Section 264 of the Delaware General Corporation Law (the "DGCL") and Section 18-209 of the Delaware Limited Liability Company Act (the "Act"), the undersigned corporation has executed the following Certificate of Merger:

1. The name of the surviving corporation is **Tangoe US, Inc.**, a Delaware corporation (the "Surviving Corporation"), and the name of the limited liability company being merged into the Surviving Company is **Tangoe, LLC**, a Delaware limited liability company (the "Terminating LLC").
