AMENDED AND RESTATED ASSIGNMENT OF TRADEMARKS

THIS AMENDED AND RESTATED ASSIGNMENT OF TRADEMARKS (this "Assignment") is made and entered into with an effective date of July 1, 2018, by and between COOLIBAR, INC., a Delaware corporation ("Assignor"), and OLIVARIUS HOSPITALITY CALIFORNIA, LLC, a California limited liability company ("Assignee"), with reference to the following facts:

RECITALS

A. Assignor is the owner of the trademarks identified on Schedule I hereto (the "Trademarks"). Schedule I is incorporated herein by this reference.

B. Assignor and Assignee are parties to that certain Brand Purchase Agreement of even date herewith, pursuant to which Assignor has agreed to assign the Trademarks, all related goodwill, and the entire business to which the Trademarks pertain, including all books and records associated with the business (as required by § 10 of the Lanham Act), to Assignee.

C. Assignor and Assignee previously executed an Assignment of Trademarks as of July 1, 2018, pursuant to the Brand Purchase Agreement, and now desire to amend and restate such Assignment of Trademarks by entering into this Agreement.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. **Assignment.** Assignor hereby assigns, sells, transfers, sets over and delivers unto Assignee all of Assignor's estate, right, title and interest in and to the Trademarks and the Trademarks' registration (or application therefor), together with (i) all of the goodwill of the business associated with the Trademarks and symbolized by the Trademarks, (ii) all of Assignor's rights under any and all contracts and agreements relating to the Trademarks, (iii) all of Assignor's claims for damages by reason of past infringement of the Trademarks, with the right to sue for and collect the same, for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, and (iv) all of Assignor's business, which is ongoing and existing, pertaining to the Trademarks. Assignor hereby constitutes and appoints Assignee, or Assignee's attorney, to endorse and/or file a record of all assignments, applications, documents, papers, and instruments necessary for Assignee or its transferees, successors or assigns, to maintain title to and the right to use the Trademarks and to prosecute the application for registration thereof.

2. **Acceptance.** Assignee hereby accepts all of Assignor's estate, right, title and interest in and to the Trademarks and the Trademarks' registration (or application therefor).

3. **Counterparts.** This Assignment may be executed in any number of counterparts and each such counterpart shall for all purposes be deemed to be an original and all such counterparts together shall constitute but one and the same instrument.

4. **Binding Effect.** This Assignment shall be binding upon and inure to the benefit of the successors, assignees, personal representatives, heirs and legatees of all the respective parties hereto.

5. Governing Law. This Assignment shall be governed by, interpreted under, and construed and enforceable in accordance with, the laws of the State of California.

6. Further Assurances. Assignor covenants and agrees that it will, from time to time at the request of Assignee, execute, acknowledge and deliver such other instruments of assignment as Assignee may reasonably request and take such other action as reasonably may be requested by Assignee.
