8. All outstanding membership interests of the Merged Company will automatically be cancelled and retired and will cease to exist, and no consideration will be delivered in exchange therefor. All membership interests of the Surviving Company shall remain outstanding following the consummation of this merger.
9. This merger is to be effective as of 12:02 a.m. on January 1, 2017.


