## INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT is entered into as of April 3, 2019, by and among PACIFIC WESTERN BANK (“**Bank**”) and GLOBALWEBINDEX HOLDINGS LIMITED, a limited company registered in England and Wales (“**Parent**”), TRENDSTREAM LIMITED, a limited company registered in England and Wales (“**Trendstream**”), GLOBALWEBINDEX LIMITED, a limited company registered in England and Wales (“**GWI Limited**”), GLOBALWEBINDEX INC., a Delaware corporation (“**GWI Inc.**”) GLOBALWEBINDEX LABS LIMITED, a limited company registered in England and Wales (“**Labs**”, and together with Parent, Trendstream, GWI Limited, and GWI Inc., collectively, “**Grantors**,” and each, a “**Grantor**”).

### RECITALS

A. Bank proposes to enter into a Loan and Security Agreement with Grantor as of the date hereof (as amended, restated, supplemented or otherwise modified from time to time, the “**Agreement**”; capitalized terms used herein are used as defined in the Agreement).

B. Bank is willing to enter into the Agreement, but only upon the condition, among others, that Grantor shall grant to Bank a security interest in certain Copyrights, Trademarks and Patents to secure the Obligations, as set forth in the Agreement.

C. The Grantors propose to enter into debentures (“**Debentures**,” and each, a “**Debenture**”) with Bank for the purpose of providing security to the Bank.

NOW, THEREFORE, Grantor agrees as follows:

### AGREEMENT

To secure its obligations under the Agreement and under any other agreement now existing or hereafter arising among Bank and Grantors, each Grantor grants and pledges to Bank hereunder, under the Agreement, and in the Debentures, a security interest in all of such Grantor’s right, title and interest in, to and under the Intellectual Property Collateral (including without limitation those Copyrights, Patents and Trademarks listed on Exhibits A, B and C hereto), and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part thereof.

This security interest is granted in conjunction with the security interest granted to Bank pursuant to the Agreement and the Debentures. The rights and remedies of Bank with respect to the security interest granted hereby are in addition to those set forth in the Agreement and the other Loan Documents, and those which are now or hereafter available to Bank as a matter of law or equity. Each right, power and remedy of Bank provided for in the Agreement or any of the Loan Documents, or now or hereafter existing at law or in equity shall be cumulative and concurrent and shall be in addition to every right, power or remedy provided for herein and the exercise by Bank of any one or more of the rights, powers or remedies provided for in this Intellectual Property Security Agreement, the Agreement or any of the other Loan Documents, or now or hereafter otherwise existing at law or in equity, shall not preclude the simultaneous or later exercise by any person, including Bank, of any or all other rights, powers or remedies. Notwithstanding the foregoing, in the event of any conflict between this Intellectual Property Security Agreement and the Agreement, the Agreement shall control.

Grantors represent and warrant that Exhibits A, B, and C attached hereto set forth any and all intellectual property rights in connection to which Grantors have registered or filed an application with either the United States Patent and Trademark Office or the United States Copyright Office, as applicable.
