## RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE dated as of March 29, 2019 (this "Release") is made by PNC Bank, National Association, as Administrative Agent (the "Agent") for the Lenders (as that term is defined in that Amended and Restated Credit Agreement dated as of April 12, 2012, by and among Automated Business Power, Inc. the Administrated Agent, and Lenders party thereto ("Credit Agreement") under that certain Trademark Security Agreement, dated as of November 20, 2008 (the "Trademark Security Agreement") by and between Automated Business Power, Inc. (the "Grantor") and the Agent.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on November 20, 2008 at reel 003891, frame 0476, the Grantor granted to the Agent, for the benefit of the Lenders, a continuing security interest in all of Grantor's right, title and interest in, to and under its owned or thereafter acquired Trademark Collateral (as defined in the Trademark Security Agreement), including those trademark and service mark registrations and applications set forth on Schedule 1 attached hereto; and

WHEREAS, the Grantor has requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral.


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Trademark Collateral, (b) release its security interest in the Trademark Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Agent in the Trademark Collateral.
