relating to the Marks, claims for past, present and future infringements of the Marks, including the right to collect damages, profits and costs, both in equity and law, for any infringement or infringements of the Marks, accruing on or before the Effective Date.

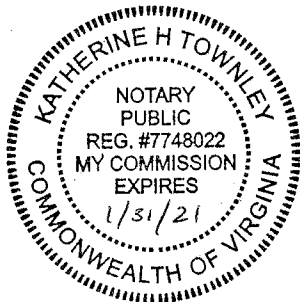
