Plenovo, Inc., a corporation organized and existing under the laws of the State of Delaware, hereby certifies as follows:

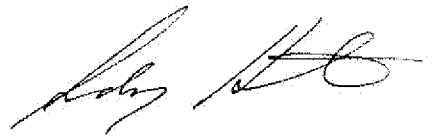
