TRADEMARK ASSIGNMENT NUNC PRO TUNC

WHEREAS, Golden State Vintners, a corporation organized and existing under the laws of the State of California ("GSV California"), was the applicant/registrant and owner of all right, title and interest in and to the trademarks and/or service marks registered and/or pending registration in the U.S. and/or foreign jurisdictions as listed in the Schedule A attached hereto (hereinafter, the "Trademarks");

WHEREAS, Golden State Vintners, Inc., a corporation organized and existing under the laws of the State of Delaware ("GSV Delaware"), shared and shares common ownership with and is a company related to GSV California;

WHEREAS, The Wine Group LLC, a limited liability company organized and existing under the laws of the State of Delaware ("TWG") acquired the entire business of GSV California and GSV Delaware on or around July 10, 2004 (the "2004 Acquisition"); and


WHEREAS, GSV California and GSV Delaware intended to convey the Trademarks to TWG shortly following the 2004 Acquisition;

NOW, THEREFORE, effective *nunc pro tunc* on July 9, 2004, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, GSV California and GSV Delaware hereby memorialize their prior understanding that GSV California has sold, assigned, and transferred to GSV Delaware its entire right, title, and interest in and to the Trademarks, together with the goodwill of the business associated with the Trademarks, including all applications and registrations for the Trademarks in the U.S. and any foreign jurisdiction, and the right to sue for past and future infringement of the Trademarks.


GSV California confirms that this assignment was completed in anticipation of the ultimate transfer of the Trademarks by GSV Delaware to TWG, which occurred shortly following the 2004 Acquisition. Both GSV California and GSV Delaware confirm that TWG is or is deemed to be the current owner of the Trademarks, subject to any security interests thereto conveyed by TWG.
