**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK  
COLLATERAL**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this "Release") is made as of April 6, 2019 ("Effective Date"), by U.S. BANK NATIONAL ASSOCIATION, ("US Bank"), in its capacity as collateral agent for each member of the Lender Group and the Bank Product Providers (in such capacity, together with its successors and assigns in such capacity, "Collateral Agent"), in favor of SALEM COMMUNICATIONS HOLDING CORPORATION, a Delaware corporation ("Grantor").

WHEREAS, reference is made to that certain Indenture, dated as of May 19, 2017 (the "Indenture"), by and among Salem Media Group, Inc., a Delaware corporation (the "Issuer"), the Guarantors party thereto, and U.S. Bank National Association, as Trustee and the Collateral Agent;

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of May 19, 2017, by and among Grantor and Collateral Agent, which was recorded with the United States Patent and Trademark Office on September 13, 2018, at Reel 6436, Frame 0710, (as amended, restated, supplemented, or otherwise modified and in effect from time to time, the "Trademark Security Agreement"), Grantor granted to Collateral Agent a security interest in all of Grantor's right, title, and interest in and to the Trademark Collateral (as such term is defined in the Trademark Security Agreement); and

WHEREAS, Collateral Agent now desires to release its security interest in the Trademark Collateral, including, without limitation, the trademark registration listed on Schedule 1 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby covenants and agrees as follows:

1. Without representation or warranty of any kind or nature, Collateral Agent hereby terminates, releases, and, discharges its security interest in the Trademark Collateral granted pursuant to the Trademark Security Agreement, and reassigns to Grantor all right, title, and interest of Collateral Agent in the Trademark Collateral pursuant to the Trademark Security Agreement.

2. Collateral Agent hereby agrees to duly execute, acknowledge, procure, and deliver any further documents and to do such other acts, in each case at the Issuer's expense, as may be reasonably requested by the Issuer to effect the release of the security interest in the Trademark Collateral contemplated hereby.
