WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on October 24, 2016 at Reel/Frame 5906/0251;

WHEREAS, in reliance of the Grantor's representations and warranties concerning the transactions referenced in that certain Officer's Certificate, the Agent has agreed to release, discharge, terminate and cancel its security interest in certain specified collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

- 1. <u>Defined Terms</u>. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement, Patent Security Agreement, Copyright Security Agreement or Trademark Security Agreement as applicable.
- 2. <u>Release of Specified Collateral</u>. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to (x) the patents and patent applications set forth Schedule A attached hereto (the "<u>Released Patent Collateral</u>"), (y) the copyright registrations and applications set forth Schedule B attached hereto (the "<u>Released Copyright Collateral</u>") and (z) the trademark registrations and applications set forth Schedule C attached hereto (the

"Released Trademark Collateral"), arising under the Security Agreement, Patent Security Agreement, Copyright Security Agreement or Trademark Security Agreement as applicable. If and to the extent that the Agent has acquired any right, title or interest in and to the Release Patent Collateral, Released Copyright Collateral or Released Trademark Collateral under the Patent Security Agreement, Copyright Security Agreement or Trademark Security Agreement, as applicable, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.

- 5. <u>Governing Law</u>. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
