## **ASSIGNMENT OF TRADEMARKS and DOMAIN**

This ASSIGNMENT OF TRADEMARKS and DOMAIN ("**Assignment Agreement**"), is made and entered into this \_\_\_ day of December, 2018, by and between Samuel D. Sweet, Trustee of the Bankruptcy Estate of King Par, LLC, Michigan Eastern Bankruptcy Court Case 4:16-bk-31984 ("**Assignor**") and DGW Enterprises LLC, a Michigan limited liability company ("**Assignee**").

1. **Assignment.** For the sum of Five Thousand Dollars (\$5,000) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor conveys, transfers and assigns to Assignee all of Assignor's right, title and interest in and to:

(a) the trademarks, service marks, logos, or other identifiers identified on Schedule A attached hereto including any derivations thereof (the "**Assigned Trademarks**"), together with the goodwill of the business connected with the use of, and symbolized by, the Assigned Trademarks;

(b) the domain names, kingpar.com and kingpar.net, including the current registrations thereof with Network Solutions LLC (the "**Assigned Domains**");

(c) the trademark registration(s) set forth on Schedule A hereto and all renewals thereof; and

(d) all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world.

2. **Transfer of Assigned Domains.**

(a) On the date hereof, Assignor shall execute all documents, papers, forms and authorizations provided by Assignee, and assist Assignee in other actions necessary to effectuate the transfer of ownership and control of the Assigned Domains to Assignee, and cause the Assigned Domains to be registered in the name of Assignee.

(b) The Domain Name will be deemed transferred when:

(i) the applicable WHOIS database identifies Assignee as the registrant of the Assigned Domains; and

(ii) the Assignee has administrative and technical access to the Assigned Domains.

(c) Assignor and Assignee will work cooperatively to complete the domain transfer within sixty (60) days of approval by the Bankruptcy Court of this Agreement.

3. **Payment.** Within ten (10) business days of approval of the Bankruptcy Court of this Agreement, Assignee will pay to Assignor the sum of Five Thousand Dollars (\$5,000).


4. Further Actions. Following the date hereof, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents prepared by Assignee, as may be reasonably necessary to effect, evidence or perfect the assignment of the Assigned Trademarks and Assigned Domains to Assignee.

5. Assignor's Representations. Assignor agrees to assign its interests in the Assigned Trademarks and Assigned Domains, if any, free and clear of all liens, claims, interests, and encumbrances of whatever kind or nature pursuant to section 363 of the Bankruptcy Code without further order of the Bankruptcy Court. However, Assignor makes no representations or warranties to Assignor concerning the ownership, value, validity or extent of the interests to be assigned identified in paragraph 1 of this Assignment Agreement.

6. Counterparts. This Assignment Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Assignment Agreement delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment Agreement.

7. Successors and Assigns. This Assignment Agreement shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.
