**TERMINATION AND RELEASE OF ABRIDGED INTELLECTUAL PROPERTY  
SECURITY AGREEMENT**

This Termination and Release of Abridged Intellectual Property Security Agreement (this “Release”), dated this 2nd day of April, 2019, is by Bank of Montreal, a Canadian chartered bank acting through its Chicago branch (the “Bank”).

A. WHEREAS, Rage PowerSports, LLC (“Grantor”), granted the Bank a security interest in (i) its trademarks and trademark applications, including without limitation those set forth on Schedule A, (ii) its associated goodwill in each of the foregoing, and (iii) all of its proceeds and benefits in each of the foregoing (collectively, the “Intellectual Property”), pursuant to an Abridged Intellectual Property Security Agreement, dated April 30, 2016 (the “Security Agreement”);

B. WHEREAS, the Bank recorded its interest in the Intellectual Property with the United States Patent and Trademark Office (the “USPTO”) on May 2, 2016 in Reel 5783 Frame 0158; and

C. WHEREAS Grantor requests that the Bank release any and all right, title, and interest in and to the Intellectual Property and the Bank agrees to release any and all such right, title, and interest.

NOW, THEREFORE, FOR VALUE RECEIVED, the Bank agrees as follows:

1) The Bank does hereby (a) unconditionally terminate and release the Security Agreement and its security interest in and to the Intellectual Property and all rights therein of any type or description, and (b) reassign, grant, and convey to Grantor, without any recourse, any and all of the Bank’s right, title, and interest in and to the Intellectual Property, including any goodwill therein that the Bank may have acquired.

2) The Bank hereby authorizes Grantor (or its authorized representative) to file copies of this Release with the USPTO, and any other document with any other filing office necessary to memorialize this Release and to extinguish the Bank’s rights and interest in the Intellectual Property.

3) This Release is governed by the law of the State of Wisconsin without respect to its conflict of laws principles.

4) This Release shall be binding upon the Bank and its successors and assigns and inures to the benefit of Grantor and its successors and assigns.
