RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (the "Release") dated as of April 8, 2019 is made by GOLUB CAPITAL LLC in its capacity as administrative agent for the Lenders (in such capacity, "Agent"), in favor of VALANT MEDICAL SOLUTIONS, INC., a Washington corporation (the "Grantor").

WITNESSETH

WHEREAS, the Grantor, certain financial institutions party thereto (the "Lenders"), and the Agent, among others, are parties to that certain Loan and Security Agreement, dated as of October 10, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement");

WHEREAS, pursuant to the Loan Agreement, the Grantor executed the Intellectual Property Security Agreement, dated as of October 10, 2017 (the "Intellectual Property Security Agreement"), and recorded with the U.S. Patent and Trademark Office on October 11, 2017 at Reel/Frame No. 6180/0503, pursuant to which the Grantor granted and pledged to the Agent for its benefit and the benefit of the Lenders a first priority security interest in all of Grantor's right, title and interest in, to and under its Intellectual Property Collateral (as defined in the Intellectual Property Security Agreement);

WHEREAS, the Grantor has requested that the Agent release its security interest in all right, title and interest in, to and under the Intellectual Property Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Agent, for itself and the Lenders, hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under all of the Intellectual Property Collateral, including the trademark registrations set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Intellectual Property Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Agent for its benefit and the benefit of the Lenders may have obtained in, to and under the Intellectual Property Collateral under the Loan Agreement and the Intellectual Property Security Agreement. The undersigned hereby authorizes the Grantor and Grantor's agents, representatives and other authorized persons to record this Release with the U.S. Patent and Trademark Office at Grantor's sole expense.
