**RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY**

**THIS RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY** (this “Release”) is made as of June 14, 2018 (“Effective Date”) by Credit Suisse AG, Cayman Islands Branch (the “Administrative Agent”), in favor of Travelport LP (f/k/a Worldspan, L.P.) (“Grantor”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Credit Agreement or the Intellectual Property Security Agreement (as defined below), as applicable.

**WHEREAS**, Grantor, the Administrative Agent and the other parties thereto entered into that certain Second Lien Credit Agreement dated December 7, 2006 (as amended, supplemented or otherwise modified from time to time, the “Credit Agreement”), which required the parties to enter into the Intellectual Property Security Agreement (as defined below);

**WHEREAS**, Grantor and the Administrative Agent entered into that certain Second Lien Intellectual Property Security Agreement dated December 7, 2006 (the “Intellectual Property Security Agreement”), under which Grantor granted to the Administrative Agent, for the benefit of the Secured Parties, a security interest in and to all of Grantor’s right, title and interest in and to the Intellectual Property Collateral, including those listed on Schedule 1 hereto; and such Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on December 12, 2006, at Reel 3442, Frame 0949 and on December 12, 2006, at Reel 018616, Frame 0539; and

**WHEREAS**, Grantor requests a specific release of the security interest granted and recorded against the Intellectual Property Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby, on behalf of itself and the Secured Parties, (i) terminates the Intellectual Property Security Agreement, (ii) releases any and all liens, security interests, right, title and interest the Administrative Agent, on behalf of itself and the Secured Parties, may have in, to or under the Intellectual Property Collateral, and (iii) re-assigns to Grantor, any right, title or interest the Administrative Agent, on behalf of itself and the Secured Parties, may have in, to or under the Intellectual Property Collateral.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.


