NUNC PRO TUNC ASSIGNMENT OF TRADEMARK RIGHTS

This Nunc Pro Tunc Assignment of Trademark Rights ("Assignment"), effective December 10, 2018 (the "Effective Date"), is made by and between CRESOX, a Limited Private Company located at A-40, Manghopir Road, S.I.T.E. Karachi, Pakistan ("Assignor") and Usman Shafi, an individual located at 50 Wood Ford Avenue, Gantshill, Essex, IG26XQ, United Kingdom ("Assignee").

WHEREAS, Assignee desires and agrees to acquire Assignor's entire rights, title, and interest in and to the Mark and the goodwill of the business symbolized thereby for valuable consideration.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignor hereby irrevocably assigns to Assignee, including Assignee's successors and assigns, all of Assignor's rights, title, and interest in and to the Mark, all common law rights therein, and all applications and registrations that may have been filed or issued with respect thereto, together with the goodwill symbolized and associated with the Mark, and the right to sue for damages for all past infringements occurring prior to the execution date of this Assignment, and to any and all marks and registrations which may evolve therefrom, *nunc pro tunc*, effective September 1, 2018.

2. Assignor also assigns to Assignee all of its rights, title, and interest and to the Mark in all foreign countries, and all applications for registration of the Mark in foreign countries and any registration(s) that may evolve and issue therefrom.

3. Assignor hereby requests the Commissioner of Patents and Trademarks of the United States of America, whose duty it is to issue trademark registrations, to issue the Certificate of Registration, Renewal, or Assignment for any registration and pending application of the Mark to Assignee, its successors, and assigns, in accordance with the terms of this Assignment of Trademark Rights agreement.




4. Assignor further agrees, without further consideration, to cause to be performed such lawful acts and to execute such further documents as Assignee may reasonably request to fully effectuate this *Nam Pro Tunc* Assignment of Trademark including, but not limited to, the execution of assignments in recordable form in each jurisdiction where the trademark application(s) or registration(s) of the Mark may be issued or pending.

5. Assignor hereby appoints Marc J. Kesten, Esq. the power to insert on this Assignment any further identification that may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.
