INTELLECTUAL PROPERTY ASSIGNMENT

This Intellectual Property Assignment (this "Agreement") is made by and between nVent Services GmbH, Mühlenstrasse 26, Schaffhausen, Schaffhausen 8200, Switzerland ("Assignor"), and nVent Solutions (UK) Limited, 3 Rutherford Road, Stephenson Industrial Estate, Washington, United Kingdom, NE37 3HX ("Assignee"). "Party" shall refer to each of, and the "Parties" shall refer collectively to Assignor and Assignee.

WHEREAS, Assignor manufactures and sells distance, position, and vibration sensor systems and related systems for turbine engines, and provides other related services to customers (the "Business") and in the course of that Business has developed and acquired right, title, and interest in and to certain Intellectual Property;

WHEREAS, Assignee wishes to acquire the Intellectual Property, all current registrations thereof, and the goodwill in connection therewith; and

WHEREAS, the Parties wish to have Assignor assign all of its right, title, and interest in and to the Intellectual Property, all current registrations thereof, and the goodwill associated therewith, to Assignee, in accordance with the terms and conditions of this Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby expressly acknowledged, the Parties hereby agree as follows:

1. Assignment. Assignor agrees to assign to Assignee all of Assignor's right, title and interest in and to the Intellectual Property, all current applications and registrations related thereto, and the goodwill in connection therewith, as well as all of Assignor's right, title and interest in and to any and all claims and demands it may have, at law or in equity, for past infringement of the Intellectual Property, and agrees to sign any supplementary confirmatory assignments needed to ensure that the Intellectual Property is transferred to Assignee.

2. Definition. "Intellectual Property" shall mean all of the following in any jurisdiction throughout the world: the patents listed on Exhibit A and any and all related patents, patent applications, continuations, continuations-in-part, divisions and reissues, and patent disclosures; the trademarks, and trademark registrations therefore, listed on Exhibit B and the goodwill connected with the use of and symbolized by the foregoing; and, other intellectual property rights held by Assignor and arising in connection with the Business, including without limitation copyright and neighboring and related rights, moral rights, business names and domain names, rights in get-up and trade dress, goodwill and the right to sue for passing off or unfair competition, rights in designs, rights in computer software, database rights, rights to use, and protect the confidentiality of, confidential information (including know-how and trade secrets), and all other intellectual property rights, in each case whether registered or unregistered and including all applications and rights to apply for and be granted, renewals or extensions of, and rights to claim priority from, such rights and all similar or equivalent rights or forms of protection which subsist or will subsist now or in the future in any part of the world.

3. Ownership of the Intellectual Property. Assignor acknowledges the ownership of the Intellectual Property by Assignee. Assignor is a "related Company" within the meaning of 15 U.S.C. §1127 and Assignor's use of the Intellectual Property pursuant to this Agreement

inures to the benefit of Assignee. Nothing in this Agreement conveys to Assignor any right, title or interest in or to the Intellectual Property.

4. Specific Undertakings. (a) Each Party agrees to execute, without further compensation, any and all documents necessary to effectuate the terms of this Agreement, even if such documents have not been expressly identified herein; (b) Assignor agrees that it will not challenge or attack Assignee's rights in and to the Intellectual Property or the validity of this Agreement; (c) Assignor agrees that it will not take or fail to take any action which, by the taking or failure to take such action, has a result of impairing the rights of Assignee, will not use the Intellectual Property for, on, or in connection with any goods or services, and will not do anything else inconsistent with the rights of Assignee; (d) Assignee agrees that it will not take or fail to take any action which, by the taking or failure to take such action, has a result of impairing the rights of Assignor and will not do anything else inconsistent with the rights of Assignor; (e) Assignee agrees that it will not challenge or attack the validity of this Agreement; and (f) should the need arise, the Parties agree to cooperate with one another to take steps to prevent the possibility of, and to eliminate or minimize any customer confusion arising in the future.

5. Representations and Warranties. Assignor represents and warrants that:

(a) Assignor is the owner of the patents identified in the attached Exhibit A and of the trademark registrations identified in the attached Exhibit B;


(b) Assignor has not previously assigned any rights in and to the Intellectual Property, or the registrations thereof;
