**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of April 4, 2019 (“Release”), is made by Bank of America, N.A., as Administrative Agent (“Administrative Agent”) in favor of the grantors listed on Exhibit A hereto (each a “Grantor”, and collectively, the “Grantors”).

WHEREAS, pursuant to that certain Collateral Agreement, dated as of March 27, 2013, as amended and restated as of June 18, 2015 (as amended, supplemented or otherwise modified from time to time, the “Collateral Agreement”), Assumption Agreement dated as of August 30, 2016 (as amended, supplemented or otherwise modified from time to time, the “Assumption Agreement”), and Grant of Security Interest in Trademark Rights dated as of August 30, 2016 (“Trademark Grant”), each by and among the Grantors and Administrative Agent, each Grantor granted to the Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in and to such Grantor’s Trademarks; and

WHEREAS, the Trademark Grant was recorded at the United States Patent and Trademark Office (“USPTO”) on September 15, 2016 at Reel 5878 Frame 0046.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Secured Parties, and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Collateral Agreement, Assumption Agreement, or Trademark Grant, as applicable.

SECTION 2. Termination and Release. Administrative Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the security interest in and to each Grantor’s Trademarks, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Collateral Agreement, Assumption Agreement, or Trademark Grant; and

(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, the Administrative Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.



