TRADEMARK ASSIGNMENT

1. Assignor hereby assigns to Assignee all Assignor's right, title, and interest in and to the Marks, the Applications and Registrations, together with the goodwill of the business symbolized by the Marks, the Applications and Registrations, and all rights to damages and profits, due or accrued, arising out of past infringements of said Marks, the Applications and Registrations, and the right to sue for and recover the same. Assignor hereby assigns to Assignee the entire business associated with the Marks and the Registrations being transferred.
2. Assignor shall promptly, upon the request of Assignee, execute such other documents and/or instruments of assignment, transfer and conveyance as Assignee may reasonably request to permit Assignee to record the assignment made by this instrument or any other documents Assignee may reasonably deem necessary or advisable to effectuate the terms and intent of this Trademark Assignment.
