**RELEASE OF INTELLECTUAL PROPERTY SECURITY INTERESTS**

This Release of Intellectual Property Security Interests (“Release”) is granted and conveyed as of April 4, 2019 by Bank of America, N.A. (“Collateral Agent”), whose full address is 333 S. Hope Street, Suite 1300, Los Angeles, California 90071, in favor of Standard Aero Limited (formerly known as Vector Aerospace Helicopter Services Inc.), (“Standard Aero”), a Canada corporation, having its chief executive office at 4551 Agar Drive, Richmond, British Columbia, Canada, V7B 1A4 (“Grantor”). Capitalized terms used but not otherwise defined herein have the meanings given them in the Security Agreement.

WHEREAS, the Collateral Agent and Grantor are parties to (a) a Canadian Security Agreement dated as of July 7, 2015 (“First Security Agreement”), notice of which was recorded on July 7, 2015 at the United States Patent and Trademark Office (“PTO”) at Reel/Frame 5570/0213 and Reel/Frame 036125/0591 and (b) a Canadian Security Agreement dated as of January 17, 2018 (“Second Security Agreement” and, together with the First Security Agreement, the “Security Agreements”), notice of which was recorded on January 23, 2018 at the PTO at Reel/Frame 6256/0447;

WHEREAS, pursuant to the Security Agreements, Grantor granted to the Collateral Agent, for the ratable benefit of itself and the other Canadian secured parties, a security interest and lien in all of its property, including the US Intellectual Property; and

WHEREAS, Grantor has requested that Collateral Agent terminate, release and reassign its Security Interests in all right, title and interest of Collateral Agent in, to and under all of the US Intellectual Property and the Collateral more fully identified in Schedule A attached hereto and made a part hereof, together with the underlying goodwill associated with the business in association with which the intellectual property is used (collectively, “US IP Collateral”).

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, Grantor and Collateral Agent hereby agree as follows:


1. All of Collateral Agent’s security interests, grants, liens, pledges, mortgages, and other encumbrances of any kind whatsoever created against the US IP Collateral pursuant to the Security Agreements (collectively, the “Security Interests”) are hereby automatically terminated, released and discharged, and the Collateral Agent shall sign any additional termination documents reasonably requested by Grantor, at Grantor’s cost and expense, as shall be necessary to effect the termination, release and discharge of all of the Security Interests. Collateral Agent hereby authorizes Grantor, or Grantor’s authorized representative, to record this Release with the PTO.
2. If and to the extent that Collateral Agent has acquired any right, title or interest in or to any of the US IP Collateral, it hereby assigns and transfers such rights, title or interest to Grantor, along with any goodwill in the US IP Collateral that the Collateral Agent may have acquired.
3. This Release is governed by and is to be construed and interpreted in accordance with the laws of the Province of Ontario and the federal laws of Canada applicable therein. This Release may be executed and delivered by facsimile or other electronic means and such facsimile or other electronic means shall constitute an original document.
