TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT ("Assignment"), is effective as of 27th day of March, 2019 between GW Pharma Limited, a limited company organized under the laws of the United Kingdom, having its registered address at Sovereign House, Vision Park, Chivers Way, Histon, Cambridge CB249BZ, United Kingdom ("Assignor"), and GW Research Limited, a limited company organized under the laws of the United Kingdom, having its address at Sovereign House, Vision Park, Chivers Way, Histon, Cambridge CB249BZ, United Kingdom ("Assignee"). RECITALS:

2. **Rights**. The foregoing assignment includes any and all renewals thereof, together with the right to bring suit and collect for past, present and future infringements thereof.
3. **Further Assurances**. Assignor shall, without further consideration, execute any additional documents as may be reasonably requested by Assignee to prove and record this Assignment.
4. **Binding Effect**. This assignment and all terms hereof shall be binding upon and inure to the benefit of the parties and their respective heirs, personal and legal representatives, successors and assigns.


5. **Counterparts.** This Assignment may be executed in one or more counterparts, each of which will be deemed to be an original, but all of which together shall constitute one and the same instrument.
