TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "*Termination and Release*") is granted as of April 10, 2019 by **GOLUB CAPITAL LLC**, as collateral agent (the "*Collateral Agent*"), in favor of **ANAQUA, INC.**, a Delaware corporation, and **LECORPIO, LLC**, a Delaware limited liability company (collectively, the "*Grantors*").

WHEREAS, the Grantors executed and delivered a Trademark Security Agreement, dated as of July 21, 2017 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "*Grant*"), granting the Collateral Agent a security interest in and lien on certain Trademarks and Trademark applications defined and described therein, which was recorded with the United States Patent and Trademark Office ("*USPTO*") on August 1, 2017 at Reel/Frame Nos. 6120/0696 and 6120/0717;

WHEREAS, the Grantors requested that the Collateral Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantors in, to and under all of the Trademark Collateral defined and described in the Grant (the "*Trademark Collateral*") as herein provided; and

WHEREAS, the Grantors requested that the Collateral Agent provide a document suitable for recording in the USPTO to evidence the release of the Collateral Agent's security interests in and liens on the Trademark Collateral as herein provided.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby:

1. terminates the Grant and releases, terminates and discharges all liens on and security interests in, and reassigns to the relevant Grantor all right, title and interest in, to and under, all Trademark Collateral, and all goodwill associated therewith, including those Trademarks and Trademark applications identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded at the USPTO.
