ASSIGNMENT OF TRADEMARKS

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is agreed as follows:

1. Assignor hereby assigns and transfers to Assignee the entire right, title and interest in and to the Trademarks, together with the goodwill associated therewith, all rights of action resulting from prior infringement or other unauthorized use of any Trademark, and all rights as a party in any opposition or similar proceedings including the right to sue for and recover all damages from any past or future infringements or other violations of the Trademarks.

2. The Assignor hereby undertakes at any time upon reasonable request to execute such documents and take such further actions as may be necessary to evidence the assignment of the Trademarks to the Assignee, and to enable the Assignee to obtain and maintain registrations for the Trademarks, all without further consideration but at the sole expense of the Assignee.
