## **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of April 12, 2019, and made by **EMPIRE OFFICE, INC.**, a New York corporation (the "Pledgor"), in favor of **JPMORGAN CHASE BANK, N.A.**, as administrative agent (in such capacity and together with any successors in such capacity (the "Administrative Agent")

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of December 18, 2014, made by Pledgor in favor of Agent (the "Security Agreement"), a security interest was granted by the Pledgor to Agent in certain collateral, including the Intellectual Property (as hereinafter defined);

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on December 18, 2014 at Reel/Frame 5421/0882;

WHEREAS, Agent now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Agent hereby states as follows:

1. Definitions. The term "Intellectual Property," as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the Intellectual Property listed on Exhibit A hereto.

2. Release of Security Interest. Agent hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Intellectual Property and reassigns to the person or persons legally entitled thereto all right, title and interest of Agent in the Intellectual Property.
