TERMINATION OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This **TERMINATION OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (“Termination”), dated as of February 14, 2019, is made by Golub Capital LLC (f/k/a Golub Capital Management LLC), as Administrative Agent (the “Secured Party”).

WHEREAS, Browz LLC (the “Grantor”) has granted a security interest in certain personal property to the Secured Party, including without limitation a security interest in certain copyrights, patents, trademarks and mask works (“Intellectual Property Collateral”);

WHEREAS, the security interest granted to the Secured Party was recorded at the United States Patent and Trademark Office on March 6, 2018 at Reel 6301 and Frame 0935; and

WHEREAS, the Secured Party has agreed to terminate and release its security interest in the Released Intellectual Property (as defined below).

NOW, THEREFORE, for valuable consideration, the Secured Party hereby (i) terminates and releases all mortgages, liens, and security interests granted to the Secured Party in the Released Intellectual Property, (ii) discharges, quit claims and relinquishes any and all right, title and interest Secured Party has in the Released Intellectual Property, and (iii) authorizes Grantor, and its agents, successors and assigns, to record this Termination with the United States Patent and Trademark Office to evidence the release set forth herein.

As used herein, “Released Intellectual Property” shall mean:


1. all of the Grantor’s Intellectual Property Collateral referred to on Schedule A attached hereto;
2. all goodwill of the business connected with the use of, and symbolized by, each Intellectual Property Collateral referred to on Schedule A attached hereto; and
3. all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of any Intellectual Property Collateral or (ii) injury to the goodwill associated with any Intellectual Property Collateral.
