TERMINATION AND RELEASE OF SECURITY INTERESTS IN CERTAIN TRADEMARKS (“Release”), dated as of April 10 , 2019, by **BANK OF AMERICA, N.A., F/K/A NATIONSBANK, N.A.**, a national banking association, which is party to that certain Security Agreement dated as of February 3, 1997 (as amended and in effect from time to time, the “Security Agreement”), among Martha Stewart Living Omnimedia, Inc. (F/K/A Martha Stewart Living Omnimedia LLC) (“Pledgor”) and Bank of America, N.A. F/K/A NationsBank, N.A.

WHEREAS, pursuant to the terms of that certain (i) Security Agreement, recorded with the PTO on or about February 5, 1997 (Reel Number 1549 and Frame Number 0566) and February 13, 1997 (Reel Number 1558 and Frame Number 0500) and (ii) Amendment to Security Agreement, dated as of March 30, 1999 between the Pledgor and Bank of America, N.A. F/K/A NationsBank, N.A., as bank, and recorded with the PTO on or about April 15, 1999 (Reel Number 1918 and Frame Number 0391), each for the purpose of securing certain obligations of Pledgor to Bank of America, N.A. F/K/A NationsBank, N.A., the Pledgor granted to Bank of America, N.A. F/K/A NationsBank, N.A., a security interest in and lien on, and collaterally assigned to Bank of America, N.A. F/K/A NationsBank, N.A. all of its trademarks, trademark registrations and associated goodwill, including, without limitation, the trademarks identified on Exhibit A attached hereto) (such trademarks referred to herein as the “Named Trademarks”); and

WHEREAS, Bank of America, N.A. F/K/A NationsBank, N.A., has agreed to terminate and release its security interest and all of its right, title and interest in each of the Named Trademarks as herein provided;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank of America, N.A. F/K/A NationsBank, N.A. and the Pledgor hereby agree as follows:

1. **Release and Assignment**. Bank of America, N.A. F/K/A NationsBank, N.A., hereby terminates and releases its security interest in and lien on all of the Pledgor’s Named Trademarks, and Bank of America, N.A. F/K/A NationsBank, N.A. hereby assigns and transfers to the Pledgor, without recourse, all of Bank of America, N.A. F/K/A NationsBank, N.A.’s right, title and interest in and to each of the Named Trademarks and the related trademark registrations and goodwill, effective as of the date set forth above.
2. **Acknowledgment and Acceptance**. The Pledgor hereby acknowledges and accepts the foregoing release and assignment by Bank of America, N.A. F/K/A NationsBank, N.A.
3. **Counterparts**. This Release may be executed in any number of counterparts which shall together constitute one and the same agreement.
