**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN  
INTELLECTUAL PROPERTY**

This Termination and Release of Security Interest in Intellectual Property ("IP Release") is made as of April 15, 2019, by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, a German banking corporation (the "Collateral Agent") in favor of COLORADO BELLE GAMING, LLC, a Nevada Limited Liability Company with an address at 6595 S. Jones Blvd., Las Vegas, Nevada 89118, and EDGEWATER GAMING, LLC, a Nevada Limited Liability Company with an address at 6595 S. Jones Blvd., Las Vegas, Nevada 89118 (each, a "Grantor" and collectively, the "Grantors").

W I T N E S S E T H:

WHEREAS, the Grantors entered into a certain Confirmatory Grant of Security Interest in United States Intellectual Property dated February 26, 2019 (the "IP Security Agreement") with Collateral Agent, notice of which was (i) recorded on February 27, 2019 at the United States Patent and Trademark Office at reel/frame 6575/0245 and (ii) filed with the United States Copyright Office on February 26, 2019, with receipt No. 1-3FGHPTQ, dated March 1, 2019.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

WHEREAS, the Grantors granted the Collateral Agent, under the terms of the IP Security Agreement, a continuing security interest (the "Security Interest") in favor of the Collateral Agent, in and to (i) each such Grantor's Trademarks, including Trademarks listed in **Schedule A**, (ii) each such Grantor's Patents, including Patents listed in **Schedule B**, (iii) each such Grantor's Copyrights, including Copyrights listed in **Schedule C** and (iv) each such Grantor's Licensed Trademarks, including Licensed Trademarks listed in **Schedule D**.


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademarks, Patents, Copyrights and Licensed Trademarks as herein provided.
