FIRST AMENDMENT TO TRADEMARK SECURITY AGREEMENT

THIS FIRST AMENDMENT TO TRADEMARK SECURITY AGREEMENT (the "Amendment"), is dated as of March 18, 2019, and entered into by and between INTERNATIONAL BUILDING MATERIALS, LLC, an Oregon limited liability company ("Grantor"), and WELLS FARGO BANK, NATIONAL ASSOCIATION ("Lender").

RECITALS

A. Grantor, HDTC, LLC, and Lender are parties to an Amended and Restated Credit Agreement dated as of the date hereof (as amended, supplemented or restated from time to time, the "Credit Agreement"). Capitalized terms used in these recitals have the meanings given to them in the Credit Agreement unless otherwise specified.

B. To induce Lender to provide the financial accommodations described in the Credit Agreement, Grantor entered into that certain Trademark Security Agreement, dated as of January 31, 2019, with Lender (the "Agreement").

C. The Grantor has requested that Lender modify and amend certain terms of the Agreement as set forth herein.


NOW, THEREFORE, in consideration of the premises and of the mutual covenants and agreements herein contained, it is agreed as follows:

1. Amendment to Schedule I. Schedule I to the Agreement is hereby amended by adding the items described on Schedule A to this Amendment.
2. No Other Changes. Except as modified by this Amendment, all of the terms and conditions of the Agreement shall remain in full force and effect are hereby ratified and reaffirmed by Grantor.
3. Counterparts. This Amendment may be executed in any number of counterparts, each of which when so executed and delivered shall be deemed an original and all of which counterparts, taken together, shall constitute one and the same instrument.


