REASSIGNMENT AND RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

This Reassignment and Release of Intellectual Property Security Interest (this “**Release**”) is made as of April 8, 2019 by Silicon Valley Bank, a California banking corporation (“**Lender**”), whose address is 3003 Tasman Drive, Santa Clara, California 95054 in favor of SpineSmith Holdings, LLC, a Delaware limited liability company (“**Company**”), whose address is 4719 South Congress Avenue, Austin, Texas 78745.

Recitals

1. Lender and Company are parties to that certain Intellectual Property Security Agreement dated as of January 10, 2015 (the “**Security Agreement**”), pursuant to which Company granted Lender a security interest in certain collateral, including without limitation the patents identified therein (the “**Patent Collateral**”) and the trademarks identified therein (the “**Trademark Collateral**”).
2. The Security Agreement was recorded with the United States Patent and Trademark Office at Patent Reel/Frame 035014/0066 on February 18, 2015 and at Trademark Reel/Frame 005461/0377 on February 17, 2015.
3. Lender and Company desire that all of Lender’s rights, including any right to obtain a security interest (whether present, contingent, or otherwise), under the Security Agreement be terminated and released with respect to any and all intellectual property, intellectual property rights and proprietary rights throughout the world (whether registered or unregistered) and corresponding goodwill and other rights of Company, including all Patent Collateral set forth on Schedule A hereto and all Trademark Collateral set forth on Schedule B hereto (all of the foregoing in which Lender has been granted a security interest or any right to obtain a security interest (whether present, contingent, or otherwise) under the Security Agreement, collectively, the “**Released IP Collateral**”).

Agreement

1. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby terminates, releases and discharges fully, without recourse, representation or warranty, Lender’s security interest (whether present, contingent, or otherwise) in all right, title and interest of Company in, to and under all Released IP Collateral, and reassigns and transfers to Company, without recourse, representation or warranty, any right, title and interest that Lender may have in, to and under all of the foregoing.
2. Lender hereby authorizes Company (or its designee or authorized representative) to record this Release with the United States Patent and Trademark Office, the United States Copyright Office, any similar office or agency of the United States, any state thereof, any other country or any political subdivision thereof, or any applicable office or agency thereof. Lender agrees to execute all documents and take all actions reasonably requested by Company (at the sole cost and expense of Company) to: (a) terminate, release and discharge fully, without recourse, representation or warranty, Lender’s security interest (whether present, contingent, or otherwise) granted under the Security Agreement in all right, title and interest of Company in, to and under all of the Released IP Collateral; (b) reassign and transfer any right, title and interest that Lender may have under the Security Agreement in the Released IP Collateral to Company; and (c) perfect, register or record the rights of Company to the Released IP Collateral in connection with the release and reassignments contemplated by this Release.
3. This Release may be executed in counterparts, each of which when executed will be deemed to be an original but all of which taken together will constitute one and the same agreement. The

words "include", "including" and variations thereof will be deemed to be followed by the words "without limitation". The use of "or" will not be deemed to be exclusive.

4. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the internal laws of the state of Texas, without regard to conflicts of laws principles.


