FULL RELEASE OF TRADEMARK SECURITY INTEREST

This FULL RELEASE OF TRADEMARK SECURITY INTEREST (the “Release”) is made this 15th day of April, 2019 (the “Release Date”) granted by WILMINGTON TRUST, NATIONAL ASSOCIATION (the “Secured Party”) in favor of RELATION INSURANCE SERVICES – SPECIALTY RISK, INC. (formerly known as Summit America Insurance Services, Inc.) (the “Grantor”).

WHEREAS, the Grantor granted to the Secured Party a security interest in the trademarks listed on the attached Schedule A and the Grantor granted to the Secured Party a security interest in all of their right, title and interest in, to and under the registered trademark identified in Schedule A (hereinafter referred to as the “Collateral”) under that certain Security Agreement dated March 5, 2013.

WHEREAS, the security interest was recorded with the U.S. Patent and Trademark Office (“the USPTO”) on March 6, 2013 at Reel/Frame No. 4975/0545 (the “Security Interest”);

WHEREAS, as of the Release Date, all amounts owing and due under the Security Agreement were repaid, and upon such payment all security interests granted to Secured Party under the Security Interest were released and terminated and Secured Party wishes to further evidence such release.


NOW, THEREFORE, in consideration of the fulfillment of certain covenants made by the Grantor, and having full authority to do so, the Secured Party agrees as follows:

1. Release of Security Interest. Effective as of the Release Date, the Secured Party hereby irrevocably and forever releases and discharges its Security Interest in the Collateral, any and all of its security interest in, and all of its right, title and interest in, to and under, the Collateral granted by the Secured Party under the Security Agreement.
2. Recordation of Release. The Secured Party understands and agrees that this Release may be recorded by or for the Grantor with the USPTO.
3. Further Actions. The Secured Party further agrees to execute any other documents and take any further action reasonably necessary in any state, country or jurisdiction that the Grantor may reasonably require to effect the intent and purpose of this Release; provided, that all such documents are to be prepared by counsel to the Grantor and the cost and expense of such documents and actions shall be borne solely by the Grantor.
4. Governing Law. This Release shall be governed by and construed in accordance with the laws of the State of New York without regard to any principles of conflicts of law.
