Trademark Assignment

ASSIGNMENT OF TRADEMARKS

Effective April 1, 2019, pursuant to that certain Asset Purchase Agreement, effective as of April 1, 2019, by and among Professional Economics Bureau of America, Inc., a Minnesota corporation Minnesota having an address at 279 N. - (b) all rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;
- (c) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and
- (d) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.




