**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of April 16, 2019 (this "Release"), is made by **HERCULES TECHNOLOGY GROWTH CAPITAL, INC.** (the "Administrative Agent"), in favor of **SIGNPOST, INC.** (the "Grantor").

WITNESSETH

WHEREAS, the Administrative Agent now desires to terminate and release its security interest in and continuing lien on all right, title and interest of the Grantor in, to and under the Released Registered Trademarks, and reassign any all rights, title and interest in the same to the Grantors.

NOW, THEREFORE, the Administrative Agent, without recourse, representation or warranty of any kind or nature, and at the Grantor's sole cost and expense, hereby terminates, cancels and releases its security interest in and continuing lien on all right, title and interest of the Grantor in, to and under the Released Registered Trademarks and any and all right, title and interest of the Administrative Agent in such Released Registered Trademarks, including all goodwill associated therewith, is hereby assigned, transferred, and conveyed to the Grantor.

The Administrative Agent authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release.
