RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This Release of Security Interest in Intellectual Property is made as of April 16, 2019 (this "Release") by ECAP CAPITAL LLC, (the "Secured Party"), in favor of PACKIT, LLC, a California limited liability company (the "Grantor"). Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Intellectual Property Security Agreement (as defined below).

WHEREAS, the Grantor owns the Intellectual Property Collateral (including without limitation those Patents and Trademarks listed on Schedule A) ("Listed Intellectual Property");

WHEREAS, pursuant to that certain Notice of Grant of Security Interest dated as of May 1, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the "Intellectual Property Security Agreement"), Grantor pledged and granted to Secured Party, a continuing security interest in, all of Grantor's right, title and interest in, to and under the Listed Intellectual Property (collectively, the "Collateral"), to secure Grantor's payment, performance and observance of its obligations under the Intellectual Property Security Agreement;

WHEREAS, the Intellectual Property Security Agreement was previously recorded with the U.S. Patent and Trademark Office on June 14, 2012 at Reel No. 4801, Frame No. 0270, filing no. 900225689;

WHEREAS, Secured Party has, at the Grantor's request, agreed to release its security interest in all of the Grantor's right, title and interest in, to and under the Collateral, including the Listed Intellectual Property.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby terminates, releases and discharges fully its security interest in all of the Grantor's right, title and interest in, to and under the Collateral, including the Listed Intellectual Property.

Secured Party hereby authorizes the Grantor, or the Grantor's authorized representative, to record this Release with the United States Patent and Trademark Office. Secured Party hereby undertakes and agrees to do such things and to execute such further lawful documents, assurances, applications and other instruments as may be required to give effective legal, registered and unencumbered title to the Grantor in and to the Collateral, including but not limited to the Listed Intellectual Property and the registrations thereof all without further considerations.


