FULL RELEASE OF SECURITY INTEREST

THIS FULL RELEASE OF SECURITY INTEREST is dated as of April 17, 2019, by BANK OF AMERICA N.A., F/K/A LASALLE BANK NATIONAL ASSOCIATION, a national banking association ("Bank"), in favor of TAB PRODUCTS CO., LLC, a Delaware limited liability company, the successor in interest to TAB PRODUCTS CO., a Delaware corporation (collectively, "Tab").

WHEREAS, the Patent Security Agreement is dated as of October 22, 2002 and recorded with the United States Patent and Trademark Office on (i) October 31, 2002 at Reel 013429, Frame 0413, and (ii) January 25, 2008 at Reel 020403, Frame 0960.

WHEREAS, Bank wishes to terminate and release all of Bank's right, title and interest in and to the Intellectual Property.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank hereby terminates and releases Bank's security interest in the Intellectual Property.
