## TRADEMARK ASSIGNMENT

This Trademark Assignment is effective as January 1, 2019 (the “*Effective Date*”) and is between Ben Purdy Consulting, LLC, an Oregon limited liability company (“*Assignor*”), and Glowbox, LLC, an Oregon limited liability company (the “*Assignee*”).

WHEREAS, Assignor was formerly known as Glowbox, LLC;

WHEREAS, effective January 1, 2019, Assignor filed Articles of Amendment with the Oregon Secretary of State changing its name to Ben Purdy Consulting, LLC, and Assignee filed its Articles of Organization with the Oregon Secretary of State to be organized as Glowbox, LLC;

WHEREAS, Assignor is the owner of the trademark and federal trademark registration identified on Exhibit A (the “*Mark*”), attached to this Assignment and incorporated herein by reference; and

WHEREAS, Assignor desires to assign all of its right, title, and interest in and to the Mark, including all common law rights and good will in connection with the Mark, to Assignee, and Assignee desires to acquire all of the same from Assignor.

NOW THEREFORE, the parties hereby agree to the following:

1. Assignor hereby assigns to Assignee: (a) all of Assignor’s right, title, and interest, including common law rights, in all countries and jurisdictions of the world, in and to the Mark, and in and to all other names and marks similar to or based on the Mark Assignor has used; (b) the good will of the business associated with and symbolized by the Mark; (c) all registrations and pending applications associated with the Mark; (d) all rights of priority in the Mark in any jurisdiction of the world as may now or hereafter be granted to it by law, treaty, or other international convention; and (e) all rights, interests, claims, and demands recoverable in law or in equity, that Assignor has or may have in profits and damages for past, present, and future infringements of the Mark, including but not limited to the right to compromise, sue for, and collect said profits and damages.

2. Assignor hereby represents that Assignor has good, absolute, and marketable title to the Mark, free and clear of all liens, claims, encumbrances, and restrictions of every kind. Assignor has the complete and unrestricted right, power, and authority to assign the Mark in accordance with this assignment.




